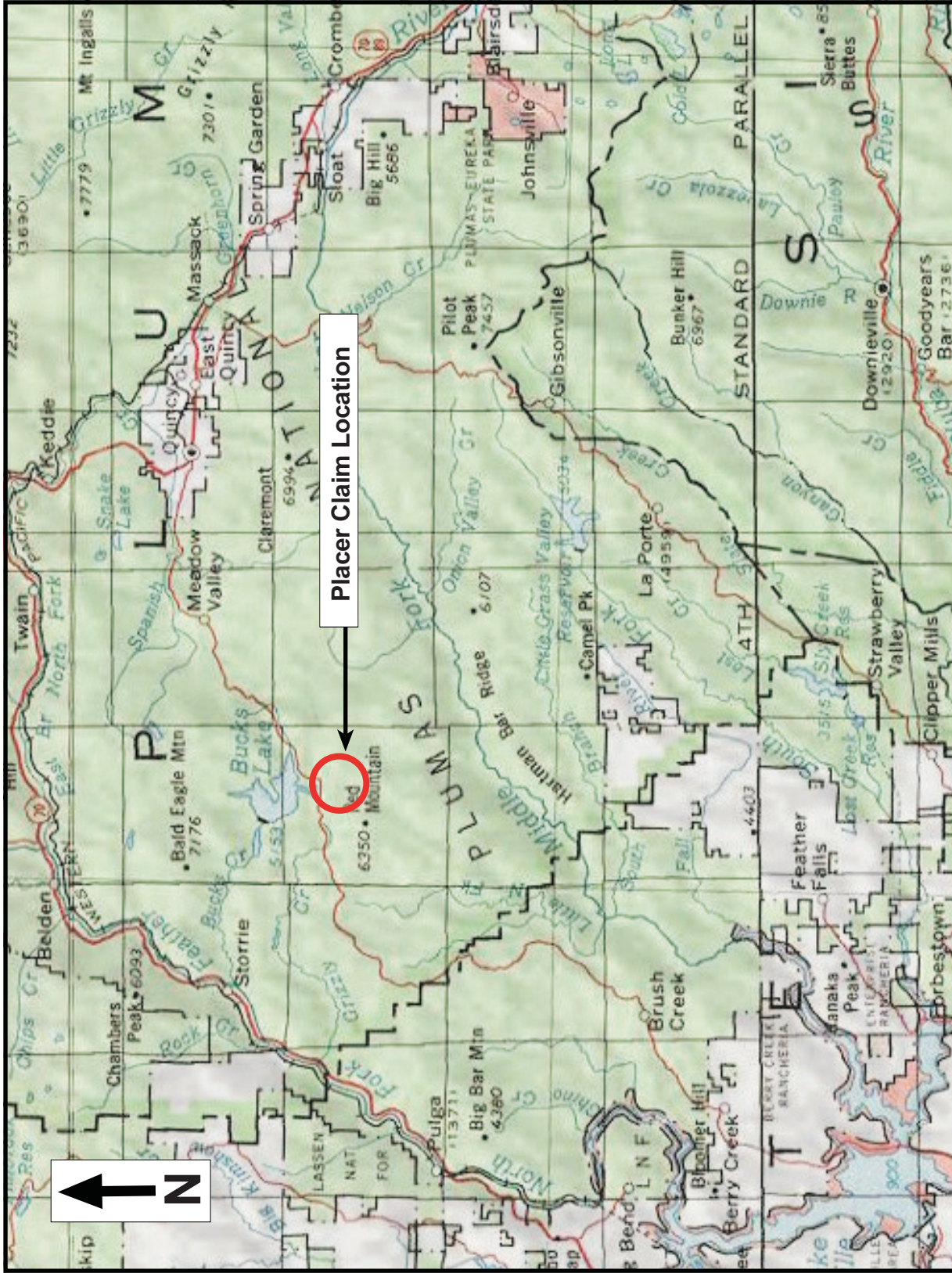

Placer Claim Location

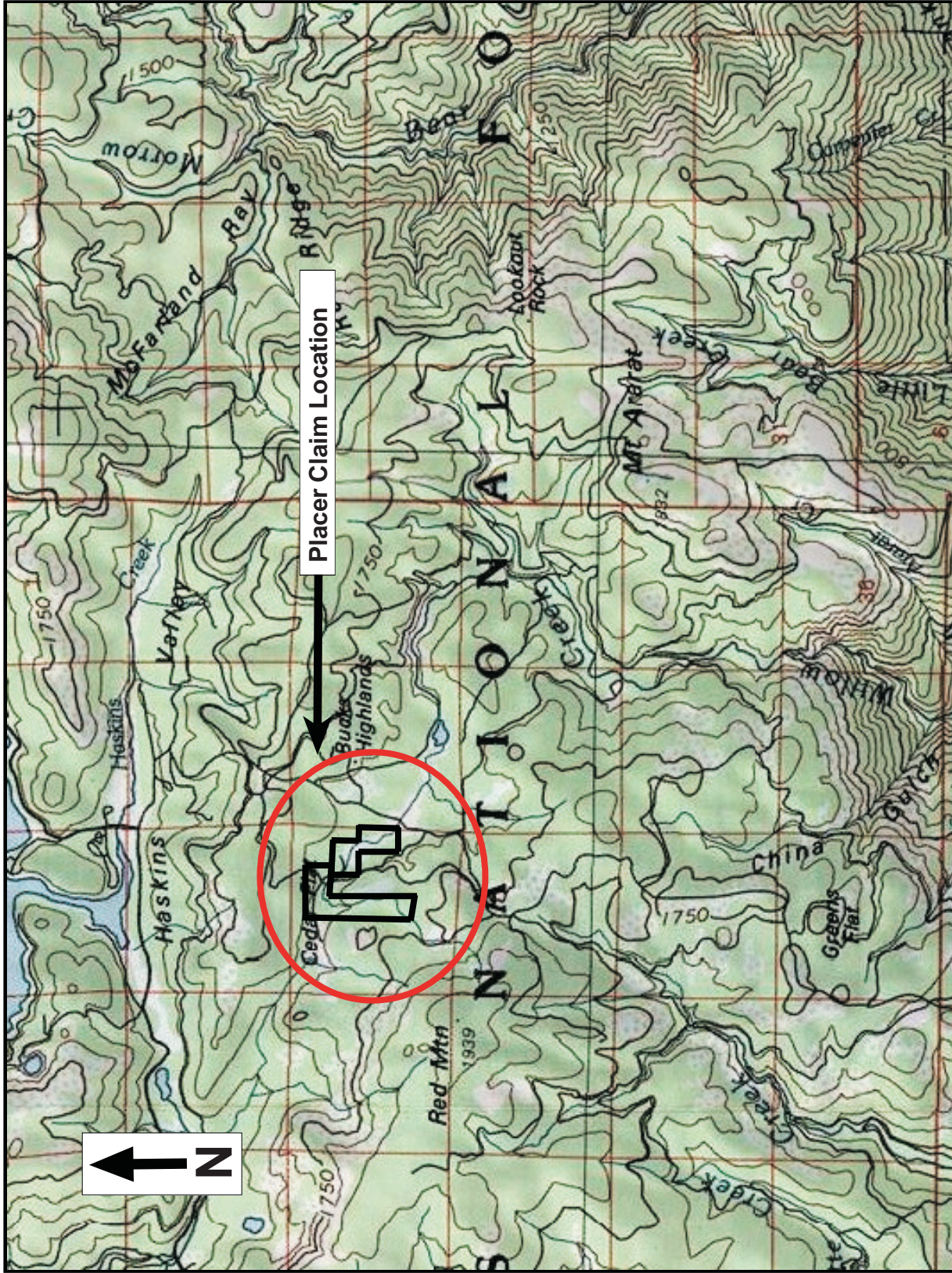

Placer Claim Location Map

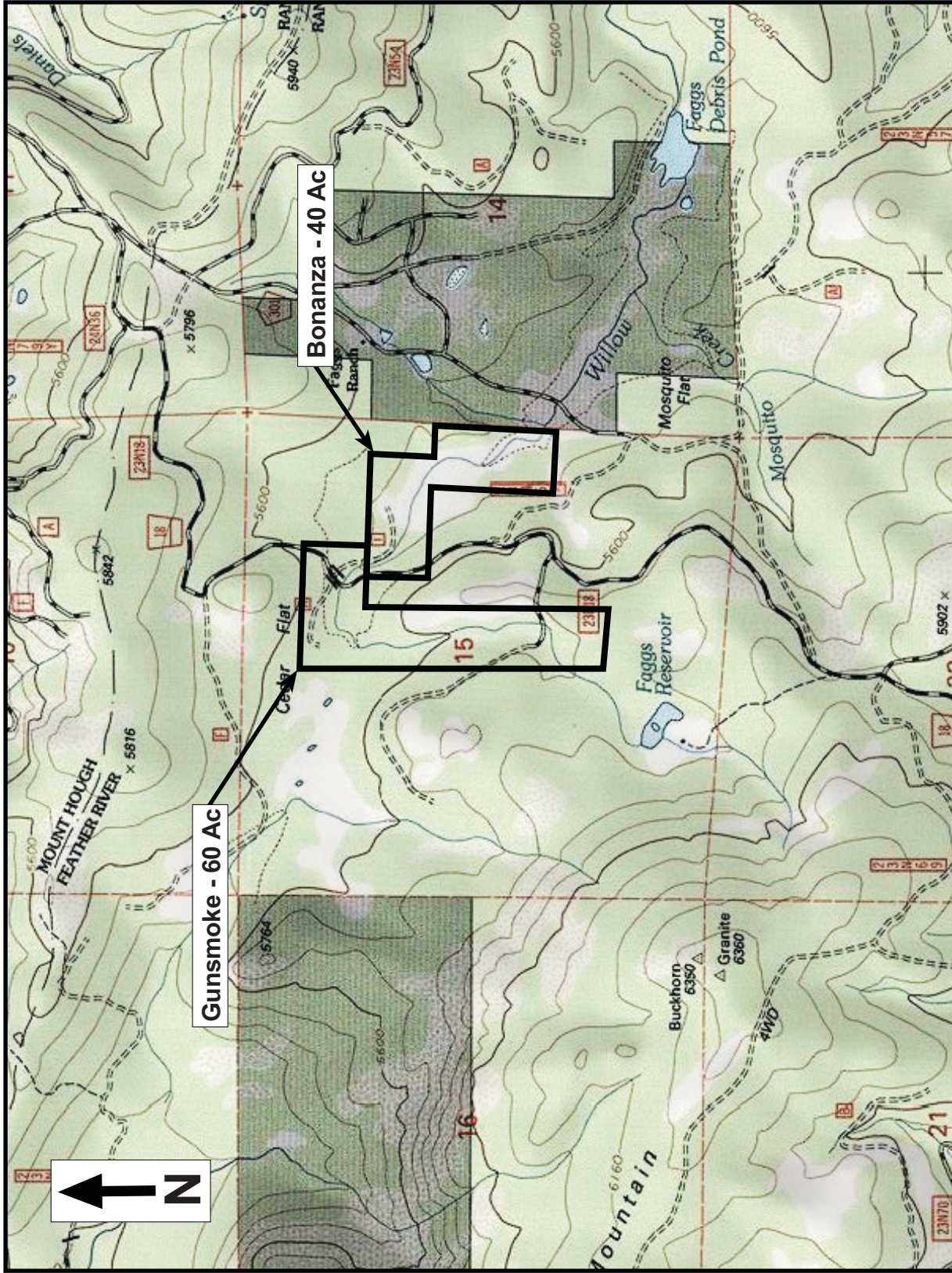

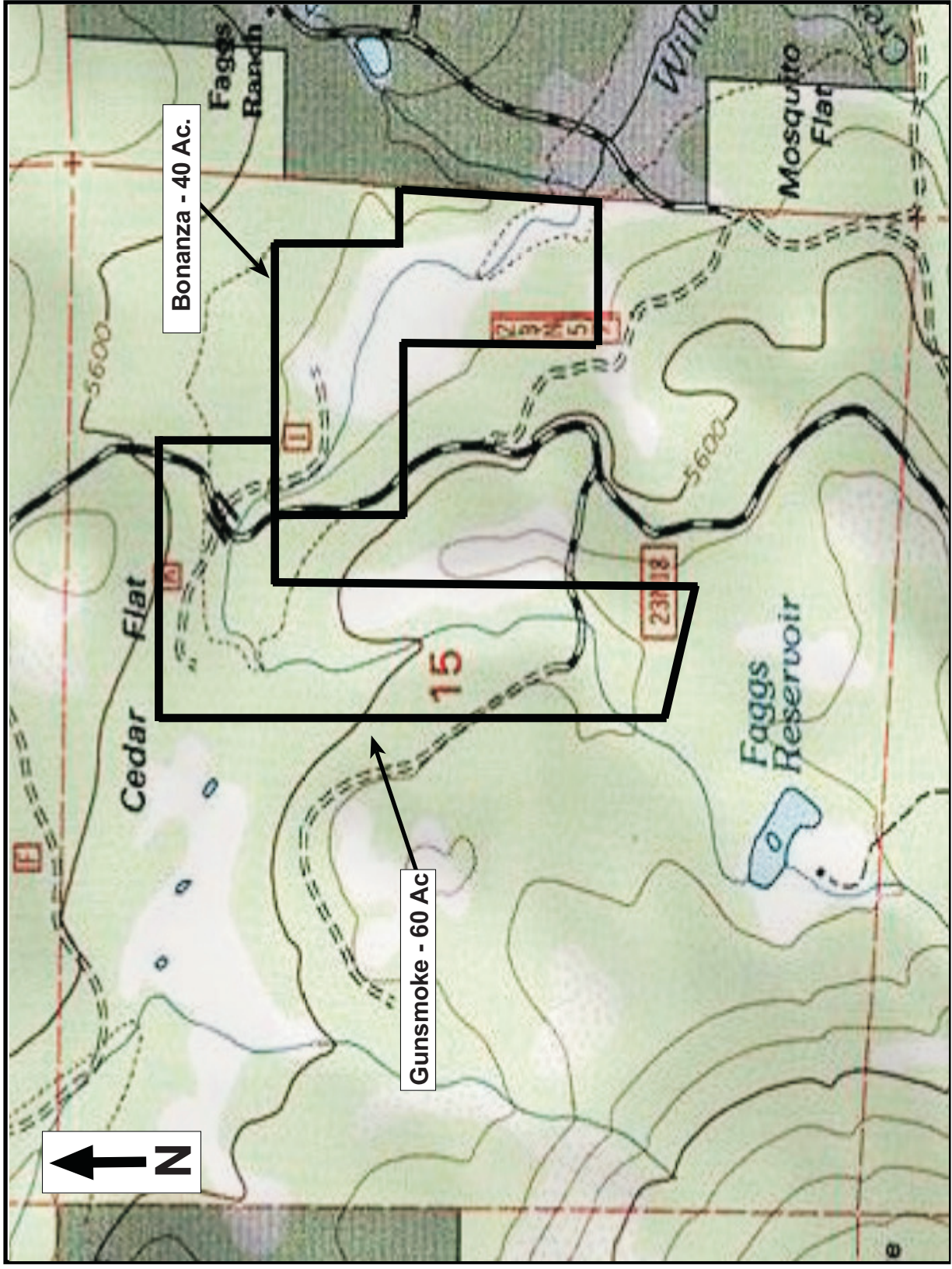

Bonanza & Gunsmoke

Start - Meadow Valley, CA

1. Head South on Bucks Lake Rd toward Schneider Creek Rd - 2 miles
2. Continue onto Big Creek Rd - 9 mile
3. Turn left onto Highlands Rd - 1 mile
4. Turn right on USF Rd 24N36 - .25 mile
5. Turn right on Forest Service Rd. 23N18 - 1 mile
6. Road enters Northeast corner of Gunsmoke placer claim.
